## **COVID RULES for the April 2021 Tallahassee Dog Obedience Club Rally Trials**

The Tallahassee Dog Obedience Club shall abide by the practices set forth by the CDC, Federal, State, County, City and Facility (Goyert Farm) policies and guideline. This event is being held in a manner that emphasizes the safety of participants and the Club will be taking necessary precautions.

### **Trial Guidelines:**

- Club Officials and participants are required to follow Leon County and Gadsden County guidelines.
- Practice social distancing consistent with current guidelines.
- A paper or cloth mask must be worn at ALL times, except in the parking lot area. Once outside the parking area the mask must be worn again.
- Hand sanitizer and antibacterial soap is readily available.
- Wash hands frequently.
- Avoid shaking hands or hugging.
- Bring your own chairs, crates, water, refreshments.
- Signed Waiver or Liability/Informed Consent Covid-19 waiver must be returned with entries.

### **The Grounds:**

- Crating areas shall be set apart for 6x6 social distancing and exhibitors must abide by these regulations.
- Crates and chairs are to be brought into the site only while dogs are showing.
- NO CONGREGATING RINGSIDE
- Trial is closed to the public.
- Waiver of Liability and Informed Consent COVID-19 Waver Hereinafter Tallahassee Dog Obedience Club will be referred to as TDOC.

"I attest to the best of my knowledge I do not have COVID-19 at the time of entering the TDOC trial and I understand the risks of unknowing exposure to this and other illnesses by or to myself, my family, other participants and third parties. I have not been tested and found positive, am not waiting for test results, and do not have any symptoms. I fully agree that TDOC, the officers, Board members and volunteers are in no way liable for any present or future COVID-19 exposure incurred at any time by any person in attendance during or after this event.

### **ADDITIONAL SITE INFORMATION**

Crating and tenting space will be available around the ring with sufficient distance as to avoid distractions and in the shade under trees.

Tents/crates will need to have at least 6 feet of distance between them to help with social distancing. No crates may be left overnight.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

Cleaning supplies and disposal sites will be available at various locations around the show grounds.

There will be no food available at the trial. There are several options nearby.

### **SAFETY, BEHAVIOR and LIABILITY**

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform exercises safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children.

Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Tallahassee Dog Obedience Club (TDOC) and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Tallahassee Dog Obedience Club (TDOC) reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Tallahassee Dog Obedience Club (TDOC) or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing in the ring.

### **REFUNDS**

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season are not permitted to compete in Rally Trials. As such, the club will refund less \$8.00 per day of the entry fee paid for bitches unable to compete for this reason upon presentation of a veterinarian certificate at least thirty minutes prior to trial start.

### **RINGSIDE**

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
